ORDER OF NOTICE
On August 10, 2006, National Grid plc, its subsidiary National Grid USA (together, Grid) and EnergyNorth Natural Gas, Inc. d/b/a keySpan Energy New England (KeySpan) jointly filed a petition with the New Hampshire Public Utilities Commission seeking annomal nursuant to PSA 360-8 Hampshire Public Utilities Commission seeking approval pursuant to RSA 369:8 and RSA 374:33 of a merger transaction that would result in KeySpan becoming a wholly owned indirect subsidiary of Grid. KeySpan serves approximately 82,000 gas customers in New Hampshire. he petition seeks certain additional regulatory approvals: (1) authority for Grid subsidiaries Granite State Electric Company, New England Power Company, New England Hydro-Transmission Corporation (NH Hydro) and New England Electric Transmission System to participate in a tion (NH Hydro) and New England Electric Transmission System to participate in a "money pool" through which KeySpan af-filiates ioan and borrow money among each other: (2) permission to consolidate the service companies of Grid and KeySpan and adopt KeySpan's formula for allocating certain service company costs to retail cuscertain service company costs to retail cus-tomers; and (3) a change in KeySpan's fiscal year. Also requested are the Commission's approval of a plan for potentially reflecting in rates, at the time of KeySpan's next rate in rates, at the time of KeySpan's next rate proceeding, certain cost savings achieved as the result of the merger. The plan includes a proposal to defer and amortize the costs of the transaction over twenty years. Finally, the petition seeks authority for KeySpan to pay dividends from its unappropriated retained earnings, unappropriated distributed earnings and accumulated comprehensive income just prior to the close of the transaction

After an initial review of the filing, the

Commission has determined, pursuant to RSA 369:8, II(b)(4), to extend the time for making its preliminary determination of adverse effects on rates, terms, service or adverse effects on rates, terms, service or operation of the public utility in the state. The petitioners' filing contains a proposed schedule that the Commission interprets as a waiver of any right the petitioners enjoy pursuant to RSA 369:8, II(b) to a decision within 60 days of the petition. The Commission requests comments at the Prehearing Conference on the proce-

dural schedule proposed by Staff.

The filing raises, inter alia, issues related to whether the transaction will have an adverse effect on the rates, terms, service or operation of ENGI and Grid subsidiaries operating in New Hampshire; whether the Transaction is lawful, proper and in the public interest and should be approved; and whether the other regulatory approvals requested by the Joint Petitioners should be granted. Each party has the right to have an attorney represent them at the party's own expense at the Prehearing Conference and

any subsequent hearings.

Based upon the foregoing, it is hereby ORDERED, that a Prehearing Conference, pursuant to N.H. Admin. Rules Puc 203.15, be held before the Commission located at 21 be hed before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on October 3, 2006 at 10:00 a.m., at which each party will provide a preliminary statement of its position with regard to the petition and any of the issues set forth in N.H. Admin. Rule Puc 203.15(c) and (d) shall be considered; and it is FURTHER ORDERED, that, immediately following the Prehearing Conference, the Joint Petitioners, the Staff of the Commission and any Intervenors hold a Technical

sion and any intervenors hold a Technical Session to review the petition and allow Joint Petitioners to provide any amendments or updates to their filing; and it is FURTHER ORDERED, that pursuant to N.H. Admin. Rules Puc 203.12. Joint Petitioners shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than Septement 18, 2006 in a peuspaper with general ber 18, 2006, in a newspaper with general circulation in those portions of the state in which operations are conducted, publication to be documented by affidavit filed with the Commission on or before October 3, 2006, and it is 2006: and it is

FURTHER ORDERED, that any party seeking to intervene in the proceeding shall submit to the Commission an original and seven copies of a Petition to Intervene with copies sent to the Joint Petitioners and the Office of the Consumer Advocate on or before September 28, 2006, such Petition stating the facts demonstrating how its rights, duties, privileges, immunities or other substantial interests may be affected by the proceeding, as required by N.H. Admin. Rule Puc 203.17 and RSA 541-A:32; and it is

FURTHER ORDERED, that any party objecting to a Petition to Intervene make said Objection on or before October 3, 2006.
