PETITION TO INTERVENE OF UTILITY WORKERS UNION OF AMERICA, AFL-CIO

Pursuant to N.H. Rev. Stat. Ann. § LV 541-A:32 (2005) and N.H. Code Admin. R. Ann. Puc 203.04, 203.05, and 203.17 (2004), the Utility Workers Union of America, AFL-CIO ("UWUA") requests leave to intervene in this proceeding, with full rights as a party to this proceeding, which concerns the August 10, 2006, "Joint Petition" of National Grid USA ("National Grid") and KeySpan Corporation ("KeySpan") (collectively, "Applicants") for approval pursuant of National Grid's proposed acquisition of KeySpan.

The application raises important issues with respect to the quality and reliability of service to be provided to customers in New Hampshire, as well as the impacts of any approval upon the workforces of both companies. UWUA urges that the Commission conduct a full investigation into the proposed acquisition and set the Joint Petition for hearing. Parties should be given a full opportunity to seek and present information concerning the proposed acquisition and its impacts to the Commission. The investigation should broadly consider all aspects of the proposal, including whether any approval should be conditioned to address potential adverse impacts.

#### II. MOTION TO INTERVENE

Applicants commenced this action by filing for Commission approval of a proposed acquisition of KeySpan by National Grid. UWUA represents a portion of the employee workforces of both of the Applicants. Specifically:

UWUA is the national union representing approximately 55,000 workers primarily in electric, gas and water industries across the United States. UWUA's principal office is at 815 16th Street, NW, Washington, D.C. 20006. UWUA, on its own and through its local unions, represents employees who work in facilities owned/operated by National Grid and/or KeySpan, and who purchase utility service from National Grid or KeySpan operating companies.

UWUA has 288 members living in New Hampshire, of whom 66 are retired. The 222 New Hampshire members who are not retired are employed by National Grid and KeySpan companies in Massachusetts but live in New Hampshire.

UWUA and its members are directly and substantially affected by the proposed acquisition, through both their employment and their status as electric utility customers in New Hampshire. Approval of the proposed transaction will affect the livelihoods, employment, and safety of UWUA members, who have long dedicated themselves to providing safe, reliable, and economic utility services. Equally important, the Joint Petition makes clear that staffing and service cutbacks are the most likely outcome of any unconditioned approval by this Commission.

For these reasons, UWUA and the employees it represents have direct and substantial interests affected by the proposed merger, and have a strong interest in ensuring that any approval of the proposed acquisition is structured or conditioned to

protect those interests. No other party can adequately protect the interests of UWUA, and its participation in this proceeding with full rights as a party is required to protect its specific and substantial interests.

UWUA asserts that its participation will enhance the development of the record in this proceeding because its members have knowledge, information, and a perspective regarding the potential impacts of the proposed acquisition that cannot be provided by other parties.

In these circumstances, UWUA asserts that the granting of this motion for leave to intervene is in the public interest.
