Re: Northern Utilities, Inc., DA 07-026 - Affiliate Agreement with Granite State Gas Transmission

Dear Ms. Howland:

Enclosed, on behalf of Northern Utilities, Inc. ("Northern"), please find an original and eight (8) copies of a Northern's <u>revised</u> affiliate agreement between Northern and Granite State Gas Transmission ("Granite") regarding the operation and maintenance ("O&M") of metering and regulator equipment ("revised affiliate M&R Agreement"). The revised affiliate M&R Agreement has been filed with the Maine Public Utilities Commission ("Maine Commission" or "MPUC"). Northern asks the New Hampshire Public Utilities Commission ("Commission") to accept this proposed <u>revised</u> affiliate M&R Agreement for filing.

To commence the instant docket, Northern filed with the Commission a copy of its February 28, 2007 filing with the Maine Commission, which included a proposed affiliate agreement between Granite and Northern. During the process of review by the Maine Commission staff, several changes where suggested, and those changes and clarifications have been incorporated into today's revised affiliate M&R Agreement.

Attached to this letter is the filing made August 1, 2007 with the Maine Commission. It includes the proposed revised affiliate M&R Agreement as Attachment Northern-1 (Revised), which articulates the respective responsibilities of Northern and Granite with regard to the operation and maintenance of M&R equipment at the stations located in Maine and New Hampshire. Also included as Attachment Northern-1 (Revised) (Redlined), is a redlined version of Attachment Northern-1 which indicates the revisions from the February 28th filing. Attachment Northern-1 (Revised) also has Exhibit "A" -- a schedule of the M&R stations in Maine and New Hampshire; Exhibit "B" -- a responsibility matrix; Exhibit "C" – Photos Showing Physical Limits of
