## <u>PARTIALLY ASSENTED-TO MOTION TO CONTINUE</u> PREHEARING CONFERENCE AND TECHNICAL SESSION

Intervenor, Hemphill Power and Light Company ("Hemphill"), moves the New Hampshire Public Utilities Commission (the "Commission") to continue the prehearing conference and technical session now scheduled for December 27, 2007, at 10:00 a.m. In support of this partially assented-to motion, Hemphill states as follows:

- 1. On November 9, Public Service Company of New Hampshire ("PSNH") filed a petition with the Commission seeking a declaratory order regarding PSNH's obligation to purchase power from Hemphill pursuant to a Commission-approved 20-year rate order.
- 2. This dispute is also the subject of civil proceedings instituted by Hemphill in Hillsborough County Superior Court, Northern Division.
- 3. On November 28, 2007, the Commission issued an Order of Notice scheduling the prehearing conference and technical session for December 27, 2007.
- 4. Due to the holiday season, undersigned counsel has a long-scheduled vacation planned for the week of December 23, 2007.
- 5. Accordingly, Hemphill requests that the Commission grant a continuance of the prehearing conference and technical session.
- 6. Counsel for PSNH, Gerald M. Eaton, Esq., assents to the relief sought in this motion but requests that, if possible, the prehearing conference and technical session be

rescheduled prior to January 10, 2008. The Office of Consumer Advocate takes no position on the motion at this time. Donald M. Kreis, Esq., on behalf of Commission Staff, does not assent to this motion.

7. None of the parties will be prejudiced by a continuance of the prehearing conference and technical session.
