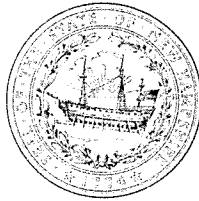


This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received Roy Morrison & Associates, LLC's (RMA) notice of intent to renew its registration as a provider of electric aggregation service in New Hampshire pursuant to Puc 2003.02. Staff has reviewed the application provided and believes that it meets the requirements of Puc 2003.02. Based on Staff's recommendation and the Commission's review, the Commission approves RMA's application to renew its registration as a provider of electric aggregation service in New Hampshire.

With regard to your request to have the re-registration fee waived, the Commission notes that your renewal application was not filed in a timely manner. It should have been filed by November 12, 2007. Therefore, the application could have been treated as a new registration and subject to the registration fee. Staff contacted you by telephone on January 10, 2008 at which time you indicated your intent to file a renewal application. Because that was less than two months past due, the Commission has decided to treat the application as a renewal and waive the registration fee for this time and this time only. Please be advised that failure to file your renewal application in the future will result in RMA having to file a completely new, original application and to pay the registration fee.

Please note the following provision of Puc 2003.02 (f): "[E]ach aggregator shall re-file with the commission an up-to-date written notice of intent to provide service as an aggregator every 2 years on or before its original notice anniversary date." RMA's original notice anniversary date is November 12, 2003 and therefore it is required to re-file an up-to-date written notice on or before **November 12, 2009** if it continues to offer and provide electric aggregation service. In addition, RMA is subject to the provisions of Puc 2004.03, telephone solicitation of customers, and Puc 2004.07, customer protections provided by aggregators.
