The regular meeting of the Laconia Water Works Board of Commissioners was called to order by Chairman Jeff Kellett at 8:00 a.m. on Thursday, February 9, 2006 in the conference room at the water treatment facility. Present were Commissioners Jeff Kellett, Norman Dutile, and Thomas Selling, Ex-Officio members Brad Fitzgerald and Paul Moynihan, Superintendent Rodger Matthewman and Clerk Cheryl Hounsell. Also present was Steve Smith and Attorney Rod Dyer. Chairman Kellett welcomed Councilman Brad Fitzgerald to the Board.

The chairman stated that we would dispense with regular business to discuss the issue that Mr. Smith and Attorney Dyer have come to discuss.

OLD BUSINESS

TOWN OF GILFORD FRANCHISE AREA-OPA, CHURCH-STEVE SMITH -Rodger stated that Steve Smith and Attorney Dyer were present representing The First United Methodist Church and OPA. Steve Smith stated that they are currently working with Opechee Construction for the Lemay property. Rodger stated that this area will need to look at being served by the Briarcrest tank with a payback being paid to Prescott Hill Associates or they would need to look at installing a pump station. Rodger further stated that we have received a check for Paul Fluet to do the franchise area calculations to determine how far we can go and still get the pressures that are required by using the capacity available from the Briarcrest tank. Rodger told the members that if the Board approves this expansion of our current franchise area, then it will have to go to the City Council for final approval. Rodger stated that this growth is going to happen with or without the Laconia Water Works. Attorney Dyer stated that it is in the best interest of the Water Department and the City of Laconia to supply water to these projects. Steve Smith stated that he looks at the two communities of Gilford and Laconia as one, whatever benefits one community will benefit both. Steve further stated that he was hired by the First United Methodist Church for their proposed project. OPA came into the picture after the process was started. Steve told the Board members that he came to Rodger concerning the franchise area and if Laconia Water Works would be willing to expand their franchise area to serve his client. At present they are looking at an easement through the Lemay property to install the water main then over to Maple to OPA and then up to Sugarbush to the church property. This would be funded 100% by the developers of these projects. Rodger stated that the City Council has already approved the franchise to the Lemay Property on Sawmill Road. A motion was made by Norman Dutile, seconded by Brad Fitzgerald to approve the expansion of the franchise area into Gilford as far as the Briarcrest tank can serve with the required pressures, to be determined by Paul Fluet. Vote: In favor – 4, Opposed – 1. The motion passes.

A motion was made by Norman Dutile, seconded by Brad Fitzgerald, to accept the minutes of January 26, 2006. The vote was unanimous.
