Dear Ms. Howland:

The City of Laconia Water Department, also known as Laconia Water Works (LWW), filed a petition on February 14, 2008 requesting authorization to expand water service into the Town of Gilford. The proposed service area is located northeast of the intersection of the Laconia Bypass and Route 11A and adjacent to LWW's most recent franchise expansion in Gilford ('Lemay Property'), authorized in DW 06-043, Order No. 24,660. The filing indicates the proposed expansion will allow residential and commercial water service to a half dozen lots in Gilford. Staff conducted a thorough review of the filing and recommends the Commission approve LWW's franchise request.

LWW intends to charge rates 15 percent higher than those charged inside Laconia as permitted by RSA 362:4 III-a (a) (1). The filing includes approval letters from the City of Laconia, the Town of Gilford, and LWW's own Board of Commissioners, as well as a letter from the New Hampshire Department of Environmental Services in support of the suitability and availability of water for the proposed expansion in compliance with RSA 374:22 III.

The proposed service area includes a medical facility, a veterinary hospital, an Elks Club lodge, and a proposed 40 unit adult community known as Wesley Woods. The filing indicates that, apart from the 15 percent rate differential, service will be provided uniformly in accordance with the utility's tariff for all of its other customers. Consistent with that tariff, water main extensions will be paid for by the developers of properties requesting service. Sewer service to the area is provided by the town of Gilford.
