This is to confirm that, on February 21, 2008, the New Hampshire Public Utilities Commission (Commission) received Integrys Energy Services, Inc.'s (Integrys) application to renew its registration as a Competitive Electric Power Supplier (CEPS) in New Hampshire pursuant to Puc 2003.01. Staff has reviewed the application provided and believes that it meets the requirements of Puc 2003.01. Based on Staff's recommendation and the Commission's review, the Commission will approve Integrys' application to be registered as a CEPS in the franchise areas of National Grid, Public Service of New Hampshire, and Unitil Energy Systems, Inc.

Please bear in mind the following provision of Puc 2003.01 (h): "[E]ach CEPS shall reregister with the commission every 2 years on or before its original registration anniversary date by filing with the commission an application for renewal. If a CEPS fails to meet its re-filing obligation, the original registration shall expire." Integrys' original notice anniversary date is February 22, 2006 and therefore it is required to re-register on or before **February 22, 2010**. In addition, Integrys will also be subject to the provisions of Puc 2004.03, telephone solicitation of customers, and Puc 2004.07, customer protections provided by aggregators.
