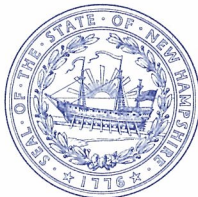

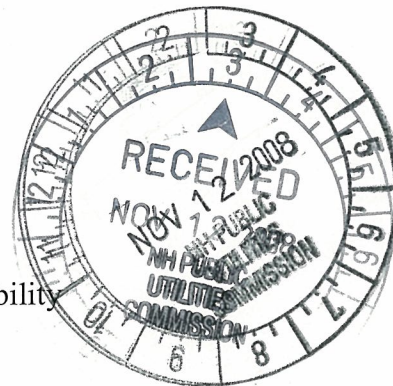

On October 28, 2008, a duly noticed Prehearing Conference was held in the above referenced proceeding. Appearances at the Prehearing Conference were entered by representatives of Public Service Company of New Hampshire, Granite State Hydropower Association, Ashuelot River Hydro, and Commission Staff. Having received no objections, all pending motions to intervene have been granted.
