Capital Reserve Fund Request

To the Parties:

On May 30, 2008, Eastman Sewer Company, Inc. (Eastman) filed a request for authorization to use \$15,800 from its Capital Reserve Fund for engineering design of upgrades to its headworks facility. Eastman indicates that these proposed upgrades are a part of its recently completed engineering study. The Capital Reserve Fund was established by the Commission in 1992 when rates were first set for Eastman, as a way of addressing Eastman's undercapitalization. (See, Order No. 20,390, *Eastman Sewer Company*, 77 NH PUC 93 (1992)).

On September 19, 2008, Commission Staff filed a recommendation that Eastman be permitted to withdraw \$15,800 from its Capital Reserve Fund for the proposed use. Staff indicated that it had reviewed the request and had propounded data requests on the company. Staff stated that the proposed upgrades to the headworks are among a number of capital improvements needed in the coming years totaling some \$540,000. Staff concluded that the proposed use of the Capital Reserve Fund is appropriate and consistent with the Commission's Order No. 20,390. Staff recommended the Commission approve Eastman's request.

Please be advised that the Commission has approved Eastman's request to withdraw \$15,800 from its Capital Reserve Fund.
