Re: Proposed Changes in Electronic Data Interchange (EDI) with Competitive Suppliers

Dear Ms. Howland:

In Docket DR 96-150 (Electric Utility Industry Restructuring), a plan entitled "Consensus Plan for the Transmission of Electronic Data in New Hampshire's Retail Electric Market" dated April 2, 1998 was developed by the EDI Working Group for the New Hampshire Public Utilities Commission to facilitate the transfer of data between regulated distribution companies and non-regulated competitive power suppliers. Since deregulation began in May 2001, PSNH has utilized the completion status codes as specified in Appendix B of the Consensus Plan. The completion status codes are utilized by the distribution companies to communicate the status of each detail record sent to the distribution company by a competitive power supplier. Specifically, the distribution company determines whether to accept or reject the detail record sent to them and, if rejected, provides the reasons for the rejection.

PSNH has received several requests from competitive power suppliers to modify the completion status codes used by PSNH so that the codes are consistent with the completion status codes utilized by other states in the Northeast. Many competitive power suppliers do business in several states and have indicated that consistent codes would result in greater efficiency. PSNH agrees that consistent codes would result in greater efficiency and has agreed to utilize the new codes in its new billing system.

In addition, PSNH is proposing to add a new service identifier in the Payment Order / Remittance Advice Transaction set. For customers with more than one location in PSNH's service territory, the service identifier further identifies the specific customer location for which a payment is applied. The service identifier will be used by PSNH to transmit customer payment information and adjustment details to competitive power suppliers that receive billing services from PSNH. As a result, competitive power suppliers will have the ability to track payments and adjustment information for each customer location. This service identifier was requested by competitive power suppliers during PSNH's review of its new billing system with the competitive power suppliers in 2007. As a result of this request, PSNH has built this capability into its EDI transaction coding within its new billing system.



PSNH has sought the input of Unitil and National Grid and both concur with this request.
