The above-referenced docket was opened in July 2008 to consider the request of the Warner Village Water District (District) to discontinue water service to certain customers and to modify the District's franchise boundaries. 
The record shows that the last communication from the District was a letter dated July 13, 2011, requesting the Commission keep this docket open, as the District was working through a waiver process with the New Hampshire Department of Environmental Services (DES). In December 2011, the Commission was copied on a letter from the District sent to DES, which contained additional information that DES was seeking. Earlier this year, DES forwarded the Commission Staff (Staff) a copy of its last communication with the District concerning this matter dated August 23, 2012. See attached.

As there has been virtually no activity in this docket during the past seven years, Staff is prepared to submit a recommendation to the Commission to close the current docket unless it hears otherwise from the District within the next 10 days. Pursuant to N.H. Admin. Rules Puc 202.03, the deadline for contacting the Commission Staff concerning this matter is July 15, 2019.

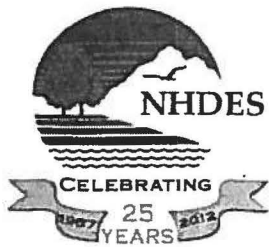

Dear Commissioner Martin:

After reviewing the most recent submissions by the Warner Village Water District, DES believes we are very close to finalizing this process. However, there are a couple of additional pieces of information we require on these lots:

1. For Lot 10-6, we need to know the original subdivision status. Either the lot was created prior to 1967, or it should have a DES subdivision approval number. Also, we need to see the proposed well location on the lot, and show that the lot meets our lot loading requirements by subtracting out the protected well radius for the proposed well and any other unusable land (such as wetlands), and provides at least 20,908 square feet of usable land. .

2. The information for Lot 10-3-1 looks good. We still need the total usable land area calculated, and we need 2 sets of subdivision plans for this lot so that we can amend the original subdivision to show on lot wells.

3. The information for Lot 3 is complete.
