## To the Parties:

On November 5, 2008, a duly noticed Prehearing Conference was held in the above referenced proceeding. The Commission's General Counsel, F. Anne Ross, presided as the Hearings Examiner and submitted a report with recommendations on November 6, 2008. Appearances at the Prehearing Conference were entered by representatives of Aquarion Water Company, the Town of Hampton, the Town of North Hampton, the Town of North Hampton Water Commissioners, Robert Cushing *pro se*, the Office of the Consumer Advocate (participating as a full statutory party), and Commission Staff.

Based on the representations contained in the Hearing Examiners Report, the Commission has granted all motions to intervene. Further, the Commission has adopted Hearings Examiner Ross's recommendations regarding Aquarion's failure to mail the order of notice directly to the town clerks of Hampton, North Hampton and Rye, and has established December 19, 2008 as the deadline for written preliminary statements by the Town of North Hampton, the North Hampton Water Commission and Mr. Cushing. Likewise, Aquarion should also file by December 19<sup>th</sup> a description of the information provided to the three towns prior to the prehearing conference.

Following the Prehearing Conference, the parties and Staff met in a technical session and, with the exception of the Town of Hampton, agreed upon the following schedule which was submitted to the Commission by letter from Staff dated November 20, 2008:
