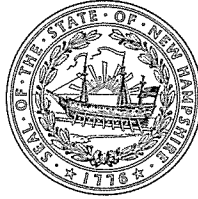

Dear Ms. Fehrman:

On August 21, 2008, TDS Telecom submitted a tariff filing waiving non-recurring installation charges in Kearsarge Telephone Company's (Kearsarge) tariff NHPUC No. 8.

Staff has examined the filings and recommended approval with the provision that the cost of these non-recurring charges be excluded if Kearsarge files for a general rate increase. The Commission accepted staff's analysis and recommendation.

For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed revisions in Kearsarge tariff NHPUC No.8 are effective as filed.
