

Re: Public Service Company of New Hampshire Stranded Cost Recovery Charge - Docket No. DE 08-114 Default Energy Service Rate - Docket No. DE 08-113

Dear Secretary Howland:

Enclosed please find Public Service Company of New Hampshire's reconciliation of Stranded Cost Recovery Charge (SCRC) and Energy Service (ES) revenues and expenses for the interim period July 1, 2009 through September 30, 2009. In the Stipulation and Settlement filed in Docket No. DE 02-127, PSNH, the Office of Consumer Advocate (OCA) and Staff agreed that PSNH would make preliminary quarterly filings reconciling SCRC and ES revenues and expenses.

The preliminary results for the second quarter of 2009 indicate the following:

- (1) The SCRC revenues have exceeded SCRC expenses resulting in an over recovery of approximately \$2.512 million, as shown on page 1 of the attached filing.
- (2) The ES expenses exceeded ES revenues resulting in an under recovery of approximately \$6.146 million, as shown on page 6 of the attached filing.
