Certification Application for Class II Eligibility pursuant to RSA 362-F

Dear Mr. Lee:

On September 23, 2008, The Lee Company (Lee) submitted an application requesting certification of its facility as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the application and recommended approval noting that the Lee application was complete on October 16, 2008.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The application indicates that The Lee Company has installed solar photovoltaic equipment with a gross nameplate capacity of .308 MW located at 2 Pettipaug Rd. in Westbrook, CT. The facility began commercial operation on June 30, 2008. According to the application, the facility's ISO-NE asset ID number and NEPOOL generation information system facility code were unavailable but will be provided to the Commission when obtained.

The Commission has reviewed The Lee Company's application and determined that it has provided all the necessary information to demonstrate that the facility is eligible for certification as a Class II facility. Therefore, the Commission hereby certifies that The Lee Company facility is a Class II renewable energy source effective October 16, 2008, and is eligible to be issued New Hampshire Class II renewable energy certificates.
