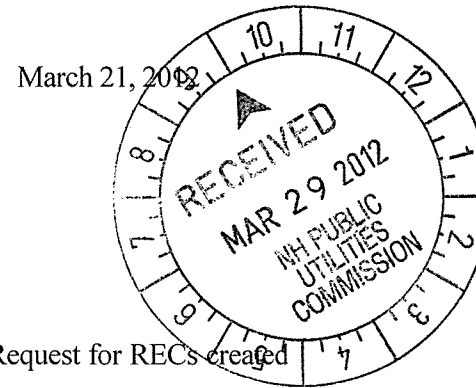

Dear Ms. Howland,

Thank you for your letter following up to our request for certificates created by Nautilus Solar Silvermine plant (NON 32755) to be banked and made available during the next trading period. Per your request below is some additional information:

1. The exact time period that Nautilus Solar has been locked out by the GIS;

Nautilus Solar was unable to access the account from June 2011 – September 2011 and thus was unable to bank the certificates created for the months of generation January 2011, February 2011 and March 2011.

2. The Certificate Numbers involved;

The following certificates remain unsettled in our account:

3. An explanation that will convince the Commissioners that these RECs should be considered for RPS compliance.

Please note that in June of 2011 our former Director of Operations, the individual responsible for managing our account, uploading generation and banking certificates, left our company. Prior to leaving he did not record the necessary process steps to manage the account and thus the certificates created in 11/2010 – 3/2011 were not banked in our account.

We request that given these circumstances and our efforts to rectify the situation as soon as we became aware of the issue, that the certificates be banked and made available during the next trading period.
