Thank you for participating in the Northeast HERS Rater Training. This letter is to inform you of your score on the certification test.

A score of 75 out of 100 is required to pass the test. Your score was 83, so you have passed the test.

You will recall that a NE-HERS rater must:

- Pass the exam
- Conduct five ratings, reviewed by a supervisor
- Conduct ratings in accordance with the manual and code of ethics
- Maintain a minimum of four hours per year of continuing education

At this point, you need to be associated with an accredited or partner HERS organization, and you should by now have identified the supervisor who is to review your first five ratings. If you have not already started those ratings, you should do so soon.

You may want to keep in mind that after October 1, 2000, only certified raters will be able to conduct NE-HERS ratings. You may want to complete your five supervised ratings well before then to assure that you will be certified by Oct 1.


