CHI Power Marketing, Inc. hereby formally requests that Renewable Energy Credits ("RECs") generated at the Salmon Falls Hydropower Project during January, February, and March 2010 be reissued in the NEPOOL GIS for use in the New Hampshire Renewable Portfolio Standard. A review of the certificates included in this request is below.

Unfortunately, due to an administrative oversight in our company the RECs generated during this time where not traded or banked within the prescribed trading period. We ask that the New Hampshire Public Utilities Commission give approval to James Webb, NEPOOL GIS Administrator, to reinstate the RECs for use in the New Hampshire RPS compliance market. As you know, the period of time for approving 2010 RECs ends on Wednesday June 15, 2011 and we request a decision be made on or before such date in order to facilitate the transfer of RECs.
