

To the Parties:

On April 21, 2009, EnergyNorth Natural Gas, Inc. d/b/a National Grid NH ("National Grid") filed an assented to motion to continue the April 22, 2009 hearing scheduled in the above referenced proceeding. In its motion, National Grid states that subsequent to a technical session at which National Grid received comments on its proposed Energy Efficiency Plan (the "Plan"), National Grid revised the Plan which was then re-circulated to the parties on April 17, 2009. In order to provide further opportunity to address the revised Plan prior to hearing, National Grid requests a continuance of the April 22<sup>nd</sup> hearing. Inasmuch as the current Energy Efficiency Plan expires April 30, 2009, National Grid also requests the Commission authorize the continued operation of the current Energy Efficiency Plan at existing levels until a decision is issued in this proceeding.

The Commission has determined that postponing the hearing will promote the orderly and efficient conduct of the proceeding. Accordingly, the April 22, 2009 hearing is postponed until further notice. Further, National Grid shall continue the operation of its current Energy Efficiency Plan until the Plan under review in this proceeding is approved.
