Registration as a Competitive Natural Gas Supplier

Dear Mr. Costello:

On April 27, 2009, Buckley Energy Group, LTD. d/b/a Santa Buckley Energy (Santa Buckley Energy) filed with the Commission an application for registration renewal as a competitive natural gas supplier (CNGS), together with a check in the amount of \$250.00. Also on April 27, 2009, in support of its application, Santa Buckley Energy filed a Continuation Certificate for the \$50,000 surety bond it submitted with its original application.

The Commission has reviewed both the Santa Buckley Energy application and the Continuation Certificate of the surety bond submitted with the application. The application, with continuation of the surety bond, meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.01. Therefore, the Commission will approve the renewal registration for Santa Buckley Energy as a CNGS in the State of New Hampshire, with the registration to be effective June 5, 2009, coinciding with the expiration of its current registration. This registration will expire at the end of business on June 4, 2011, or on the earlier termination or expiration of the surety bond.

Additionally, please bear in mind the following provisions of Puc 3003.01:

Pursuant to Puc 3003.01 (d), each CNGS applicant shall re-register with the Commission every 2 years by filing an application for renewal. Each CNGS applicant shall file an application for renewal at least 60 days prior to the expiration of its registration.

Pursuant to Puc 3003.01 (e), each CNGS shall include on each renewal application an update, including any changes, to all information contained in the previous application. If a CNGS fails to meet its re-filing obligation, the original registration shall expire.

Pursuant to Puc 3003.01 (i), a CNGS shall notify any LDC in whose service territory it intends to do business of the filing of its registration or renewal application at the time its files such application with the Commission.

Accordingly, the Santa Buckley Energy application for renewal would be due April 4, 2011.
