Re: Third Calendar Quarter Emissions Verification Summary for Certified Biomass Renewable Energy Sources

Dear Mr. Webb:

Renewable Portfolio Standard eligibility determinations of generation facilities that use biomass fuels are conditional as required by RSA 362-F:11, III. Within ten days of receiving the quarterly notice from the New Hampshire Department of Environmental Services (DES) that a facility has met DES emissions standards, the Commission must designate the facility as eligible to produce Renewable Energy Certificates (RECs).

Based on the DES recommendation received October 30, 2018, the Commission hereby certifies the following wood-fired power plants listed in **Table 1: Calendar Quarter 3, 2018 - NH REC Eligible Biomass Power Plants**, provided below, as renewable energy sources for the third quarter of 2018. These facilities meet average emission rates of 0.02 lb/MMBtu (or an alternative plan), and 0.075 lb/MMBtu, for total suspended particulate (TSP) and nitrogen oxides (NOx), respectively.

² Bridgewater Power Company qualifies for NH Class III RECs according to RSA 362-F:11 IV, which allows for a biomass facility that does not meet the particulate (TSP) requirements, but would otherwise qualify for NH RECs, to submit a plan to DES that demonstrates quantifiable emission reductions. The plan is approved by the DES and the Commission has certified the facility in accordance with the plan approved by the DES.

Please note that DES reported that the Indeck facility, located at 151 Smith River Rd., Alexandria, NH 03222, (MSS14211) did not operate during quarter 3, 2018.

A list of thermal biomass facilities that have been recommended by the DES <u>and</u> approved by the Commission as thermal renewable energy sources is provided below as **Table 2**: **Calendar Quarter 3**, **2018 - Conditionally Approved Thermal Biomass Sources**. These facilities meet average emission rates of 0.10 lb/MMBtu for TSP and best management practices for NOx.

Quarterly Emission Verification Summary reports will no longer list all thermal facilities that are rated less than 100 Mmbtu/hr design gross heat input as they are required to meet best management practices determined by the New Hampshire Department of Environmental Services during initial eligibility certification and do not require quarterly testing and approval. Further, there were no newly eligible small (<3 mmBtu/hr) thermal renewable energy sources certified during calendar quarter 3.
