Dear Mr. St. Cyr:

On September 30, 2009, you filed on behalf of Lakes Region Water Company, Inc. (Lakes Region) a notice of intent to file rate schedules. Within that notice, Lakes Region requested waiver of the filing requirements contained in Puc 1604.01(a), (1), (2), (6), (7), (9), (10), (12), (13), (17), (19), (23), (24), (25), (26) and (27). Among other things, you contend that the information that Lakes Region would be required to produce to comply with these provisions is either not available or not applicable.

On October 8, 2009, Staff filed its recommendation that the Commission grant approval stating that, after reviewing each of the waiver requests, it concurs that the information requested does not apply to Lakes Region.

The Commission has concluded that the applicable standards for a waiver are satisfied and the requested waiver is consistent with the public good. Accordingly, Lakes Region's request to waive the filing requirements contained in Puc 1604.01(a), (1), (2), (6), (7), (9), (10), (12), (13), (17), (19), (23), (24), (25), (26) and (27) has been granted. However, in the event the Commission determines that the pertinent information is otherwise relevant, it retains the authority to terminate the waiver.
