

Registration as a Provider of Electric Aggregation Service

Dear Mr. Morrison:

This is to confirm that the New Hampshire Public Utilities Commission (Commission) has received Roy Morrison & Associates, LLC's (RMA) notice of intent to renew its registration as a provider of electric aggregation service in New Hampshire pursuant to Puc 2003.02. Staff has reviewed your application and has noted the following item which must be addressed before RMA can be registered as an aggregator:

Puc 2003.02 (c) (4) requires a "toll free telephone number of the customer service contact person". You stated in the application: "No toll free phone. I dropped 800 number since no one ever called. Large institutional and industrial customers only." You must formally request a waiver of this rule, stating the reasons why this requirement is onerous and how the granting of the waiver would be in the public interest pursuant to Puc 201.05.


Puc 2003.02 (c) (5) requires a "copy of the aggregator's authorization to do business in New Hampshire from the secretary of state". According to the secretary of state's website, Roy Morrison & Associates, L.L.C. is currently "Not In Good Standing". Until that status is changed and proper authorization is obtained, the renewal application cannot be processed.

There is no renewal fee required if the renewal application is filed in a timely manner. RMA's renewal application was received November 10, 2009. Therefore check #1248 in the amount of \$250.00 is being returned.

Please address these discrepancies as soon as possible so that Staff may proceed with your request to renew your registration as an aggregator of electric services. Failure to respond in a timely manner may result in the Commission dismissing, without prejudice, RMA's application. Also, please be advised that you should reference the docket number, DM 09-223, in all future correspondence with the Commission. Should you have any questions, please do not

hesitate to contact me.
