Re: DE 10-024, Fiscal Year 2018 Renewable Energy Fund Program Budget Adjustments

To Whom It May Concern:

On March 23, 2018, Staff filed a memorandum requesting approval to amend certain Renewable Energy Fund (REF) program budgets based on current program demand and projected spending for the remainder of fiscal year 2018 (FY18). The recommended reallocation of funds will have no impact on the balance of funds allocated between the residential and non-residential program sectors (see RSA 362-F:10) and meet other statutory allocation requirements. Specific program adjustments are as follows:
