Dear Ms. Howland:

Hollis Telephone Company, Inc., Kearsarge Telephone Company, Merrimack County Telephone Company, and Wilton Telephone Company, Inc., as Joint Petitioners in the above-referenced matter (collectively, "TDS Telecom"), hereby support the "Motion for Authority to Disconnect Global NAPs," which was filed on behalf of Northern New England Telephone Operations LLC d/b/a FairPoint Communications-NNE ("FairPoint") on May 13, 2010. TDS Telecom urges the Public Utilities Commission to grant the FairPoint motion without further hearing, as the record is now closed and the Commission's Orders have now become final in this matter. In the event the Commission is unable to promptly grant the FairPoint Motion, TDS Telecom respectfully requests the Commission to direct FairPoint to cooperate with TDS Telecom in the prompt disconnection of GNAPs from the TDS Telecom networks in New Hampshire.

The Commission has already ruled that TDS Telecom is entitled to access payments from Global NAPs, Inc. ("GNAPs") for toll traffic terminated by GNAPs to the TDS Telecom networks in New Hampshire. The Commission reaffirmed its ruling in an Order Denying Reconsideration on April 2, 2010.<sup>2</sup> The Commission's Orders were not appealed. On April 13, 2010, TDS Telecom delivered a Notice of Pending Disconnection to GNAPs (and filed a copy with the Commission), stating TDS Telecom's intention to disconnect GNAPs from further termination services in New Hampshire as of May 4, 2010. The actual disconnection, however, requires

action by FairPoint to block the delivery of GNAPs traffic to TDS Telecom at the FairPoint tandem switch.

As of the present date, disconnection of GNAPS by TDS Telecom has not yet occurred, while TDS Telecom awaits further action by FairPoint.

The most efficient action would be for FairPoint to disconnect GNAPs fully from further use of the FairPoint network in New Hampshire. Such disconnection is authorized under both the Final Order and the Reconsideration Order. As the Commission recognized in the Reconsideration Order, N.H. Admin. Rule Puc 412.19 authorizes a telecommunications carrier "to disconnect non-residential customers, such as Global NAPs in this case, for violation of applicable tariff provisions, including non-payment for services rendered." Indeed, the Commission noted that its disconnection "rules do not require any action by this Commission prior to a utility disconnecting service under any of the delineated circumstances" and that "in fact, TDS was not required to petition the Commission for authority to cease allowing Global NAPs' traffic to terminate on its network." Under the Commission's Rules and Orders, FairPoint is subject to the same disconnection rights as TDS Telecom has exercised. TDS Telecom fully supports FairPoint's authority to disconnect GNAPs in New Hampshire, which will also enable TDS Telecom to disconnect GNAPs as provided in the April 13th disconnection notice.

TDS Telecom is also concerned that its own disconnection rights, which vested on May 4th, could be delayed by a dispute over the FairPoint motion. Even if FairPoint is unable to disconnect GNAPs from the FairPoint network, TDS Telecom will still require FairPoint's cooperation in the disconnection of GNAPs from the TDS Telecom networks. Thus, if it appears that FairPoint's Motion cannot be quickly granted, TDS Telecom respectfully asks that the Commission direct FairPoint to cooperate with TDS Telecom in its disconnection efforts and to use available measures to effect the immediate disconnection of GNAPs from the TDS Telecom networks in New Hampshire.
