Request:

Is there a deadline by which each utility must receive an invoice for program year 2010 expenditures? If so, please state the deadline and describe any other billing considerations of which the Commission should be aware.

Response:

Granite State Electric Company and EnergyNorth Natural Gas could process this invoice for payment in 2010 if the invoice was received no later than Thursday December 23. Alternatively, the companies could carryover any unspent funds from the 2010 program year which could then be used to pay for the SB 323 study to the extent available.

Please note, the companies did not explicitly budget for the SB 323 study in either their 2010 or 2011 energy efficiency program budgets. Funding this work may require reductions in spending for the proposed programs since the 2011 M&E funds are fully obligated to other M&E studies.
