RULEMAKING

N. H. Code Admin. Rules PART Puc 900, Net metering ORDER OF NOTICE

On February 23, 2011, the Commission voted pursuant to RSA 541-A to initiate a rulemaking for N. H. Code Admin. Rules PART Puc 900, Net metering for Customer-Owned Renewable Energy Generation Resources of 100 Kilowatt or Less rules. The Commission's Initial Proposal represents a readoption of the existing Puc 900 rules with amendments. Puc 900 sets forth definitions of terms, general rules, rights and obligations, statutory and other requirements, requirements relating to the interconnection application process, technical requirements for interconnection, description of separate compliance paths for units using inverters or meters to interface with the electrical grid and procedural requirements for all interconnected units. The proposed amendments reflect 2010 legislative changes to RSA 362-A which increase the size of eligible facilities up to 1000kW. The 2010 amendment also provided alternative payment options for customers where production from a customer facility exceeded the power consumed by the customer. Upon approval, the proposed amended rule will replace the current version of Puc 900. The readoption of the rules will assure a common expiration date for the entirety of Puc 900.

A rulemaking notice form (Notice), as required by RSA 541-A:6, was filed with the <u>Office of Legislative Services on March 10, 2011</u>. The Notice sets forth a date for a public

hearing to be held at the Commission and a deadline for submission of written comments. That notice is appended hereto.

A copy of the Rulemaking Notice will be sent to all regulated utilities and to those parties previously requesting notice of rulemakings pertaining generally to utility service and customer relations. Pursuant to RSA 541-A:6, III, notice will also be provided by public notice advertisement in a publication of daily statewide circulation.

The readoption with amendment Initial Proposal may be viewed on the Commission website, <u>http://www.puc.nh.gov/Regulatory/Docket/2010/10-216.htm</u>, or copies may be obtained from the Commission as set forth in the Notice.

Based upon the foregoing, it is hereby

ORDERED, that a Public Hearing, pursuant to 541-A:11, be held before the Commission located at 21 South Fruit Street, Suite 10, Concord, New Hampshire on April 19, 2011 at 2:00 p.m., and that the deadline for submission of materials in writing or via e-mail shall be April 29, 2011, as set forth in the Notice; and it is

FURTHER ORDERED, that pursuant to RSA 541-A:6, III, the Commission shall undertake a public notice advertisement by publishing a copy of this Order together with the Notice no later than March 24, 2011, in a newspaper with a daily statewide circulation, publication to be documented by affidavit filed with the Commission on or before April 19, 2011. 6. (a) Summary of what the rule says and the effect of the rule on those regulated:

Specifically, the proposed rule sets forth definitions of terms, general rules, rights and obligations, statutory and other requirements, requirements relating to the interconnection application process, technical requirements for interconnection, description of separate compliance paths for units using inverters or meters to interface with the electrical grid and procedural requirements for all interconnected units.

Net energy metering is a way to provide a reasonable opportunity for small customers to choose interconnected self generation, to encourage private investment in renewable energy resources, to stimulate in-state commercialization of innovative and beneficial new technology, to enhance the future diversification of the state's energy resource mix, and reduce interconnection and administrative costs.

The amendments to Puc 900 implement the 2010 amendment to RSA 362-A which increased the size of eligible facilities up to 1000kW. The 2010 amendment also provided alternative payment options for customers and provided alternative for customers where production from a customer facility exceeded the power consumed by the customer.

6. (b) Brief description of the groups affected: Any person or entity which seeks to interconnect to the electric grid with a renewable energy generation resource of 1000 kilowatts or less in capacity. Additionally affected are electric utilities which distribute electric power within the State of New Hampshire and electric suppliers within the state as defined in the rule.
