Dear NH PUC:

Please accept this letter and attached documentation, required by the New Hampshire Administrative Code Public Utility Commission Rules Pursuant Section 2504.01(a)(2)(a-e) – Location of Sources Issuing Certificates, as verifiable evidence in order to continue certification eligibility for the Monroe-Livingston landfill gas-to-energy facility located at 1241 South Road, Scottville, New York 14546, 2.4 Mega-watts:

- a) Documentation of a unit-specific bilateral contract or other legally enforceable obligation that is executed between the source owner, operator, or authorized agent and an electric energy purchaser located within the New England control area for delivery of the source's electric energy to the New England control area; <u>There are no major changes to the current</u> <u>power purchase agreement that was previously provided to the commission.</u>
- b) Proof of associated transmission rights for delivery of the source's electric energy from the generation unit of the source through the adjacent control area to the New England control area; See (d) for transmission rights delivery for the source's electric energy transmission rights NERC tags.
- c) Documentation that the electrical energy delivered was settled in the ISO-New England wholesale market system; <u>the energy purchaser is currently managing the electrical energy</u> <u>output</u>, <u>which settled electrical energy may be verified via the NEPOOL-GIS tracking</u> <u>system</u>.

- d) Documentation that the source produced, during each hour of the applicable month, the amount of megawatt-hours claimed, as verified by the GIS administrator; <u>Commission staff have been provided a Template Quarterly Report to NEPOOL-GIS for Imports submitted by energy purchaser to source owner to serve as documentation that the source produced, during each hour of the applicable month, the amount of Megawatt-hours claimed, as verified by the NEPOOL-GIS Administrator and attached attestations.</u>
- e) Confirmation that the electrical energy delivered under the legal obligation received a North American Electric Reliability Corporation ("NERC") tag from the originating control area to the New England control area. See listed NERC tags. <u>Below, please find a list of NERC tag</u> <u>confirmations for Monroe-Livingston, which may be verified via the Template Quarterly</u> <u>Report to NEPOOL-GIS as confirmation that the electrical energy delivered under the legal</u> <u>obligation received a NERC tag.</u>

## **Imported Unit Energy Seller Certification**
