Withdrawal of Registration as Competitive Electric Power Supplier

Dear Mr. Silkman:

On June 25, 2014, you filed a request with the Commission to withdraw the registration of Hannaford Energy, LLC (Hannaford Energy) as a Competitive Electric Power Supplier (CEPS). In your letter you stated that Hannaford Bros. Co. (Hannaford Bros.), Hannaford Energy's sole owner, which operates retail grocery stores in New Hampshire, is the sole customer of Hannaford Energy, and that since March 31, 2014, Hannaford Energy has not provided electric service to any of the Hannaford Bros.' grocery store accounts and that it no longer has plans to do so.

The Commission's rules governing CEPS do not provide for the rescission or abandonment of a CEPS registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 2003.01(g) (approved CEPS registration valid for five years), and Puc 2003.01(i) (CEPS to continue compliance with requirements of Puc 2000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest because the waivers will not disrupt the orderly and efficient resolution of matters before the Commission, and the purpose of the rules will be satisfied by the orderly termination of Hannaford Energy's CEPS registration.

Accordingly, Hannaford Energy's CEPS registration is deemed withdrawn and terminated effective as of the date hereof.
