Dear Mr. Unger:

On January 3, 2011, you submitted applications on behalf of Boston Community Capital Solar Energy Advantage, Inc. (BCC) requesting certification of its Adams Court A and Adams Court B customer-sited photovoltaic arrays as eligible to produce Class II renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law. Staff has reviewed the applications and recommended approval noting that the BCC applications were completed on January 3, 2011.

Class II eligibility requires that a facility began operation after January 1, 2006 and that it produces electricity from solar technologies. The applications indicate that the facilities are customer-sited photovoltaic arrays located in Boston, Massachusetts and that they began operation on November 5, 2010. The details for each facility are listed in the table on the following page.

Since the facilities are customer-sited sources, their output is not recorded in the New England Power Pool Market Settlement System and, as a result, their output must be monitored and verified by an independent monitor. The applications state that the BCC's independent monitor, PowerDash LLC, will monitor the facilities' output as required by N.H. Code of Administrative Rules Puc 2505.08 and 2505.09. These facilities' total output will also be included in the *BCC Solar Energy Advantage Inc Aggregation P* s total output reported to the NEPOOL Generation Information System under the NEPOOL GIS facility code NON 32833, as approved by the Commission on January 8, 2010.

Based on Staff's recommendation, the Commission has determined that BCC has provided all the necessary information to demonstrate that the facilities are eligible for certification as Class II facilities. Therefore, the Commission hereby certifies the BCC facilities as eligible for Class II RECs, effective January 3, 2011.

The New Hampshire Renewable Portfolio Standard certification codes for the above mentioned solar photovoltaic facilities are listed in the previous table.
