- 17. By filing this application, you acknowledge the duties of an independent monitor shall be:
 - (1) To perform an initial inspection of a customer-sited source's meter for accuracy and capability to

- measure the power produced, unless the meter is owned by a distribution company that has already inspected it pursuant to Puc 305;
- (2) To measure annually the source's electricity production or displacement used to qualify for renewable energy certificates pursuant to Puc 2505.10 or Puc 2505.11;
- (3) To report the production or displacement of electricity service to the customer and the Commission annually, no later than January 31 for the preceding calendar year; and
- (4) To perform the inspection of customer-sited projects pursuant to Puc 2507.04(h).
- 18. An independent monitor shall not receive compensation for monitoring services that is a function of the number of certificates issued to any source using the monitor.
- 19. A monitor shall provide the Commission with notice prior to discontinuing services as a monitor.

Please consider Turn Cycle Solutions and Tom Kelly as an <u>Independent Monitor</u> we are aware of the obligations and restrictions and we are willing to work within the parameters set forth below.

A review of the rules and previous requests indicates the following:

Turn Cycle Solutions and Tom Kelly confirms that our firm will be providing monitoring services for customer-sited sources located in New Hampshire that qualify for New Hampshire renewable energy certificates (RECs) as required by Administrative Rules Puc 2505.09 (found in the <u>Puc 2500</u> rules on page 16).

Turn Cycle Solutions and Tom Kelly will also perform a series of tasks required under Puc 2505.09 (h) that includes performing the initial meter inspection, measuring the source's annual production, reporting annual production to the Commission and inspecting customersited projects.

Turn Cycle Solutions agrees to the terms that of the Puc 2505.09, which forbids Tom Kelly or Turn Cycle Solutions staff from being a member of the immediate family of the owner of the source he wishes to monitor. Turn Cycle Solutions and Tom Kelly also understand that we will be restricted from selling or installing the equipment used by the source. The RPS rules also prohibit your firm from receiving compensation that is a function of the number of RECs issued to any source.

Turn Cycle Solutions commits to follow the Puc 2505.09 (h) which requires an independent monitor to conduct the following tasks:

- (1) Perform initial inspection of the source's meter for accuracy and capability to measure the power produced (unless owned by a distribution utility that has already inspected it);
- (2) Measure the source's annual electricity production or displacement;
- (3) Report the annual production or displacement of electricity by January 31st for the preceding calendar year; and
- (4) Inspect customer-sited sources to demonstrate they are installed and operating in conformance with applicable safety, zoning and building codes and that the interconnection meets Puc 900 requirements. See Puc 2507.04(h).
