On November 16, 2011, FairPoint Communications - NNE (FairPoint) filed a special contract to provide a customer with DS1 service for a period of 36 months. Staff has reviewed the documentation filed in support of the special contract and recommended that it be allowed to go into effect. According to Staff, the contract rate meets the price floor requirements of RSA 378:18-b, II.
