To the Parties:

At the request of the hearing examiner conducting the deposition of Mr. Long pursuant to Order No. 25,566 the Commission determined that scheduling one session before lunch and three sessions after lunch would facilitate the conduct of the deposition. Therefore, pursuant to RSA 365:28, the Commission approved that modification of the schedule with the understanding that the deposition of Mr. Long would conclude on September 16, 2013.

This Commission decision was communicated orally to the hearing examiner during the lunch recess on September 16, 2013, and conveyed to the parties by the hearing examiner at the beginning of the afternoon sessions on that same date.
