On December 05, 2011, Best Practice Energy, LLC (Best Practice Energy) submitted an application seeking certification as an aggregator of customer-sited photovoltaic sources that qualify for New Hampshire renewable energy certificates (RECs) pursuant to N. H. Code of Administrative Rules Puc 2506.

Staff has reviewed the application and believes it meets the requirements for certification inasmuch as you have met the registration requirements outlined in Puc 2506.01. Based on Staff's recommendation, the Commission has determined that your application meets the requirements of Puc 2506 and has approved Best Practice Energy's certification as an aggregator for customer-sited sources that qualify for New Hampshire RECs.

Additionally, please bear in mind that pursuant to NEPOOL GIS Operating Rules 2.1 (a) (vi) and (c), multiple facilities represented by the same Non-NEPOOL generator representative may elect to be treated as a single GIS generator provided: 1.) the aggregation has a total nameplate capacity of less than five megawatts; 2.) all the facilities generate electricity from the same type of source; and 3.) the facilities are located in the same state.
