Re: DE 12-043, Record Hill Wind LLC's Application for the Record Hill Wind Farm's Certification for Class I New Hampshire Renewable Energy Certificates Pursuant to RSA 362-F, Request for Additional Information

Dear Mr. Novello:

On February 16, 2012, the New Hampshire Public Utilities Commission (Commission) received an application from Record Hill Wind LLC (Record Hill) requesting certification of the Record Hill Wind Farm as a Class I renewable energy source pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. Staff reviewed your application and noted items that needed to be addressed before the application could be considered complete in a letter dated March 5, 2012. You responded in a letter and attachments received April 10, 2012.

Upon further review, Staff has noted that no reference to an interconnection agreement has been received. Puc 2502.02 (b)(8) states that the application shall include... "Proof that the applicant either has an approved interconnection study on file with the commission, is a party to a currently effective interconnection agreement, or is otherwise not required to undertake an interconnection study."

I do understand that your interconnection agreement is likely a huge confidential document, so if you can provide me with the cover page, the first few pages, the page with the name plate capacity, and signature pages, that should allow me to verify that the Interconnection agreement is valid.

Submission of the above modification and verification must be received by the Commission to complete your application. Until such time, it cannot be processed. If the requested information and documentation are not provided within ten business days of the date of this letter, your application will be denied without prejudice. Please refer to docket number **DE 12-043** in all future correspondence with the Commission. Also note


that review of submitted information would be greatly expedited if the references to attachments in the application provide specific direction including specific page numbers.
