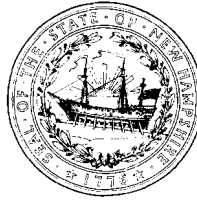

Re: DT 05-083 Investigation into Verizon Wire Centers
Clarification Regarding Suspension of Order

To the Parties:

On April 28, 2006, the New Hampshire Public Utilities Commission (Commission) issued a Secretarial Letter suspending Commission Order No. 24,598 (March 10, 2006) in Docket No. DT 05-083 pending further consideration of issues raised in various motions for rehearing and reconsideration. Because the suspension of Order No. 24,598 may affect certain tariff implementation issues that are integral to the substance of the investigation in this docket, the Commission hereby sets the following terms and conditions on the suspension, pursuant to its authority under RSA 541:5:

- any disconnect and conversion provisions based on wire center classifications in Tariff No. 84 are suspended;
- any transition timeframes based on wire center classifications in Tariff No. 84 are suspended; and
- the rejection in Order No. 24,598 of the proposed tariff revisions filed in Docket No. DT 06-012 shall remain in effect, as none of the motions for rehearing and reconsideration raise that issue.
