Re: Docket No. DT 07-011 Verizon New England, Inc. et alia Petition for Approval of Asset Transfer to FairPoint Communications, Inc. Office of Consumer Advocate Motion for Prehearing Conference

To the Parties:

The Commission is in receipt of an August 24, 2007 motion by the Office of Consumer Advocate (OCA) in the above-referenced docket requesting the scheduling of a prehearing conference before a hearings examiner. The motion describes, from the perspective of OCA, certain problems arising out of multi-level confidentiality designations made by the petitioners with respect to information provided by them in discovery. The case is scheduled for extensive hearings that begin on October 22, 2007. OCA requests that the Commission resolve these issues so that preparations for the hearings can continue on an unimpeded basis and so that the hearings themselves can be conducted in an appropriate manner.

A separate motion of OCA, also filed on August 24, 2007, requests that the Commission make specific confidentiality determinations with respect to documents provided by the petitioners in discovery. In this motion, OCA stresses that it is not itself seeking confidential treatment of the information. Rather, OCA seeks clarity about the status of these documents.

Having reviewed these pleadings, the Commission agrees with OCA that confidentiality issues raise serious concerns with respect to the Commission's ability in this proceeding "to secure a just and timely determination of the issues," which is the overall context in which the Commission interprets and applies its procedural rules. *See* N.H. Code Admin. Rules Puc 201.03 (governing construction of Puc 200 rules). The concerns relate both to the conduct of the hearings themselves and the parties' ability to prepare for the hearings.

Accordingly, the Commission has granted OCA's request for a prehearing conference before a hearings examiner. The Commission has scheduled the prehearing conference for September 6, 2007 at 9:00 a.m. and has designated General Counsel Donald Kreis to
