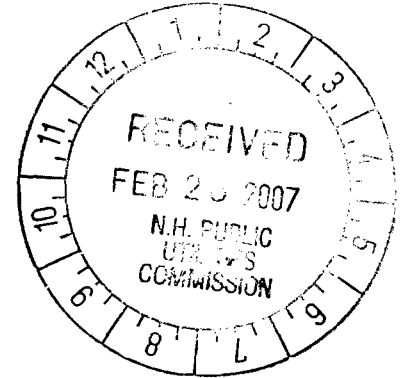

NOW COMES the City of Keene, by and through its attorneys,
DONAHUE, TUCKER & CIANDELLA, PLLC, and moves the Commission to
grant it intervenor status, without limitation, pursuant to RSA
541-A:32 and N.H. Administrative Rule, PUC 203.02, along with
the municipalities of Hanover, Newmarket, Raymond, Salem and
Seabrook ("Municipalities"), which had previously filed a
Petition to Intervene with the Commission, on February 22, 2007.
In support of this motion, the City of Keene states:
