ONE COMMUNICATIONS’ PETITION TO INTERVENE

Choice One of New Hampshire Inc., Conversent Communications of New Hampshire, LLC, CTC Communications Corp., and Lightship Telecom, LLC, all of which do business as One Communications (collectively, “One Communications”), petition to intervene in this proceeding.

One Communications’ rights, duties, privileges, immunities or other substantial interests may be affected by this proceeding. Each of the One Communications entities named above offers competitive local exchange services in New Hampshire in part by obtaining unbundled network elements, interconnection, collocation, and other wholesale services from Verizon New Hampshire. The proposed sale by Verizon of its New Hampshire operating company potentially affects the ability of One Communications to serve New Hampshire customers, and the manner in which One Communications will serve its customers after the transaction.

The interests of justice and the orderly and prompt conduct of the proceedings will not be impaired by allowing One Communications to intervene. The Commission has just opened this docket, and One Communications is filing this petition in accordance with the schedule that the Commission established in the Order of Notice.

For these reasons, One Communications requests that it be permitted to intervene.
