## PETITION TO INTERVENE OF PAETEC COMMUNICATIONS, INC. AND US LEC COMMUNICATIONS INC.

PAETEC Communications, Inc. ("PAETEC") and US LEC Communications Inc. ("US LEC") (together "Joint Petitioners") pursuant to the Order of Notice issued in this proceeding on February 7, 2007, N.H. Admin. Rules PUC 203.17 and N.H. Rev. Stat. § 541-A:32, hereby submit their petition to intervene in the above-referenced proceeding. The Joint Petitioners should be permitted to intervene on the grounds stated below.

PAETEC is a full-service, facilities-based competitive local exchange carrier that provides a broad range of integrated telecommunications services to business and residential customers in New Hampshire pursuant to authority granted by the Commission in Order No. 23,050 on October 28, 1998. PAETEC also provides competitive switched and dedicated long distance services pursuant to authority granted by the Commission in Certificate No. 31698 issued on September 3, 1998. US LEC provides switched long distance services pursuant to authority granted by the Commission in March 11, 2003. In the provision of their respective retail services, the Joint Petitioners rely to a great extent on the purchase of wholesale services from Verizon New England ("Verizon") pursuant to tariff and

contract. The ability of the Joint Petitioners to serve their respective customers depends on the uninterrupted and continued provision of these services by Verizon's prospective successor, Fairpoint Communications, Inc., under identical terms and conditions. Consequently, the issues before the Commission in this proceeding are of significant interest to both PAETEC and US LEC, and any decisions resulting from this proceeding may affect the Joint Petitioner's rights, duties, privileges, immunities or other substantial interests, including its expected operations in New Hampshire.

For the foregoing reasons, PAETEC's and US LEC's Petition to Intervene should be granted.
