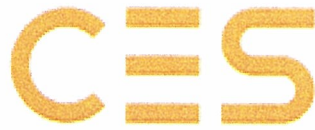

- Check for \$500 (\$250 per application).


The Company received approval from the NHPUC on June 16, 2006, to provide electric aggregation service in New Hampshire (see OM 06-080) and subsequently in 2008, 2010 and the attached Registration Application for Electricity Aggregator is intended as a request for renewal of that approval.

Similarly, the Company received approval from the NHPUC on June 28, 2006, to provide gas aggregation service in New Hampshire (see OM 06-081) and subsequent years and the attached Registration Application for Gas; Aggregator intended as a request for renewal of that approval.

The Company also became aware of that, pursuant to N.H. Code Admin. Rules Puc 3003.02(e), and that it should have filed the request for renewal of its Gas Aggregator approval at least 60 days prior to the expiration of its registration. The Company regrets missing the deadline and respectfully requests that the NHPUC consider this oversight an immaterial and unintentional violation of N.H. Code Admin. Rules Puc 3003.02(e).

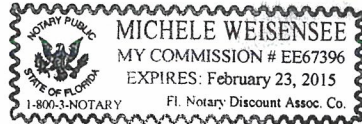

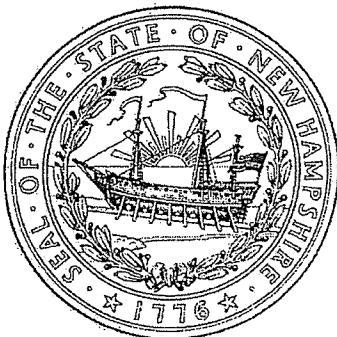

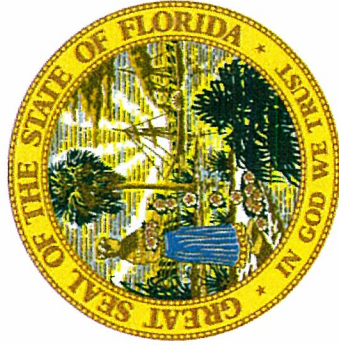
