Hearing on Permanent Rates	September 17, 2013; 10:00 AM

The above schedule provides separate tracks for either settlement or full litigation of the issues in this proceeding. If Staff and the company do not reach agreement on all the issues by June 21, 2013, Staff and the company will proceed on the litigation track. Staff expects an audit to be conducted in time for the first set of discovery. Staff and the company agree to exchange discovery and filings by email.
