Dear Mr. Tenore:

The application filed by Signal Point Corp. (Signal Point) to provide CLEC service in New Hampshire has been approved, as the accompanying certificate attests. Signal Point's registration number is CL-01-001-13.

As Signal Point conducts business in New Hampshire, the Commission expects the company to comply with all administrative rules and provide the highest level of customer service. Under its current rules, the Commission requires yearly updates of the company's progress which you will provide by filing NH Puc Forms CLEC 1 through 5 and CLEC-40 by March 31st of each year. Upon attaining its first retail customer, Signal Point must file with the Telecommunications Division NH Puc Form CLEC-12, *Initiation of Operations*. All such CLEC forms are available at our web site: www.puc.nh.gov. The Commission also requires notification from Signal Point of address changes, and of restructuring, acquisitions, or other major events regarding provision of services as outlined in Commission rules.

Please be aware that, although changes in New Hampshire telecommunications law became effective on August 10, 2012, revised forms will not be available until the Commission amends its rules. This rulemaking process will not be completed until late 2013. For your reference, the bill revising telecommunications laws can be reviewed at this location:
