**TRANSFER
AUTHORIZATION FOR RENEWABLE ENERGY CERTIFICATE
(REC) ELIGIBILITY**

On June 15, 2015, the Commission received a request from Knollwood Energy of MA (Knollwood) to transfer the Class II RECs attributable the **Joseph Shanks** photovoltaic (PV) array to the Knollwood aggregation. The facility was originally approved for REC eligibility and participation in the Solar Farm Bank aggregation on February 21, 2013. **Knollwood's request**, on behalf of the facility owner, indicates that participation in the Knollwood aggregation will begin with July 1, 2015 production. **Based on Staff's recommendation**, the Commission hereby approves inclusion of the facility in the Knollwood aggregation effective as of July 1, 2015. **The Commission also issues this certificate of eligibility to reflect the facility's new GIS Facility Code NON51366.**
