SUBJECT: DT 13-266, Notification of Sovernet Fiber Corp. to Construct and Maintain Fiber Optic Telecommunications Cable Across State-Owned Lands in the City of Lebanon

TO: Debra Howland, Executive Director

On Sept. 23, 2013, Sovernet Fiber Corp. (Sovernet) submitted a written notification to the Commission pursuant to RSA 371:17-a of its intent to construct and maintain a fiber optic cable between two existing utility poles, across state-owned land in the city of Lebanon. This notification includes:

- a) A description of the specific geographic location, which in this instance includes decimal degree coordinates as used in global positioning systems;
- b) A description of the pole locations;
- c) A copy of an application for a pole attachment license that has been submitted to the pole owners; and
- d) An affidavit signed by the officer responsible for construction of this crossing, stating that the crossing will be constructed in accordance with both the National Electrical Safety Code and any requirements of the pole attachment license.

In Staff's assessment the notification meets all the requirements of RSA 371:17-a, and therefore a license for this crossing may be issued pursuant to RSA 371:20.
