Re: Public Service Company of New Hampshire Stranded Cost Recovery Charge - Docket No. DE 13-274 Default Energy Service Rate - Docket No. DE 13-275

Dear Director Howland:

Enclosed please find Public Service Company of New Hampshire's reconciliation of Stranded Cost Recovery Charge (SCRC) and Energy Service (ES) revenues and expenses for the period April 1, 2014 through June 30, 2014. In the Stipulation and Settlement filed in Docket No. DE 02-127, PSNH, the Office of Consumer Advocate (OCA) and Staff agreed that PSNH would make preliminary quarterly filings reconciling SCRC and ES revenues and expenses.

The preliminary results for the second quarter of 2014 indicate the following:

- (1) The SCRC revenues have exceeded SCRC expenses resulting in an over recovery of approximately \$10.7 million, as shown on page 1 of the attached filing.
- (2) The ES expenses exceeded ES revenues (including Merrimack Scrubber) resulting in an under recovery of approximately \$21.8 million, as shown on page 6 of the attached filing.
