On November 12, 2013, the Commission approved the Cherry Hill Limited Partnership -- Building 11 (DE 13-301) and the Bennett Way Limited Partnership -- Building 7 (DE 13-302) photovoltaic (PV) facilities as eligible for Class II RECs effective October 17, 2013, pursuant to RSA 362-F, New Hampshire's Electric Renewable Portfolio Standard law.

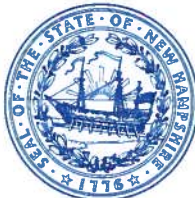
