To the Parties:

On November 29, 2016, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) requested that the Commission extend the time for filing its least cost integrated resource plan (LCIRP) from February 9, 2017, to August 1, 2017. Liberty stated that it is planning substantial changes to its supply options, and that this planning would not be sufficiently finalized by February. No party objected to the request.

Pursuant to RSA 378:38-a, the Commission found that good cause exists to waive the February 9, 2017 deadline for Liberty to file its next LCIRP, and to extend that deadline to August 1, 2017.
