On June 6, 2014, Iberdrola USA Enterprises, Inc. (Iberdrola), New Hampshire Gas Corporation (NHGC), and Liberty Utilities (Energy/North Natural Gas) Corp. (Liberty) (collectively the Joint Petitioners) filed with the New Hampshire Public Utilities Commission (Commission) a joint petition for approval of Liberty's acquisition of NHGC from Iberdrola through a stock sale. The petition, pre-filed testimony, and subsequent docket filings, other than information for which confidential treatment is requested or granted by the Commission, will be posted to the Commission's website at [www.puc.nh.gov](http://www.puc.nh.gov).

NHGC is a public utility that distributes propane air gas to approximately 1,200 customers in Keene. Iberdrola is a Maine holding company and a wholly-owned subsidiary of Iberdrola, S.A., a Spanish corporation. Iberdrola provides natural gas service to customers in New England and New York through a number of subsidiaries, including NHGC. Liberty is a public utility that provides retail gas service to approximately 86,000 customers in 31 communities throughout New Hampshire.

According to the joint petition, Liberty will buy all the outstanding stock of NHGC from Iberdrola for cash. NHGC will then merge into Liberty. The petition states that Liberty will continue to provide propane air service in Keene under the same terms and conditions of the existing NHGC tariff. The petition states that Liberty will not seek any rate changes that could affect NHGC customers and Liberty will not seek rate recovery of any acquisition premium or transaction costs arising from its purchase of NHGC.

The petition states the transaction will provide the existing NHGC system with several benefits. These projected benefits include access to Liberty's engineering and operational expertise, increased propane storage, retention of current NHGC employees, access to capital to expand service to other Keene customers, and the potential to convert the NHGC system to liquefied or compressed natural gas. The petition also states that Liberty will not seek rate recovery of costs related to NHGC's arrangement with Keene Propane Corporation.

The filing raises, *inter alia*, issues related to RSA 374:30, RSA 374:33, whether the proposed sale will have an adverse effect on rates, terms, service or operations of Liberty or the NHGC system, and whether the proposed sale is lawful, proper, and in the public interest. Each party has the right to have an attorney represent the party at the party's own expense.

**Based upon the foregoing, it is hereby ORDERED**, that a Prehearing Conference, pursuant to N.H. Code Admin. Rules Puc 203.15, be held before the Commission located at 21 S. Liberty is a public utility that provides retail gas service to approximately 86,000 customers in 31 communities throughout New Hampshire.

According to the joint petition, Liberty will buy all the outstanding stock of NHGC from Iberdrola for cash. NHGC will then merge into Liberty. The petition states that Liberty will continue to provide propane air service in Keene under the same terms and conditions of the existing NHGC tariff. 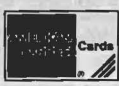

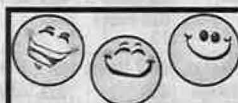

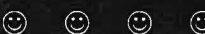
